# My full details in order to get a receipt for tax deduction

The purposely created Association de la sauvegarde la basilique de Montligeon (ASBM) governed by the 1901 French Law recognized of public interest for the enhancement of property. If you pay income tax in France, the support you provide the ASBM gives rise to an income tax rebate of up to 66% of the total amount, in the limit of 20% of your taxable income. For example: you donate  $200 \notin$  to the ASBM. Your rebate will be of  $132 \notin$ . Thus your donation really only costs you  $68 \notin$  after tax rebate.
